Cristiano Antonelli (Firenze, 1951) è professore ordinario di politica economica, nel Dipartimento di economia Salvatore Cognetti de Martiis, Fellow del Collegio Carlo Alberto, Editor della rivista 'Economics of Innovation and New Technology'.

La sua formazione include una laurea in Scienze Politiche all'Università di Torino, un master in economia all' ISTAO di Ancona. In seguito è stato junior economist nella Direzione scienza tecnologia e industria dell'OCSE negli anni 1978 e 1979 e Rockefeller Fellow nella Sloan School del Massachusetts Institute of Technology negli anni 1983-1985.

Ha insegnato nelle Università di Sassari e della Calabria, al Politecnico di Milano, e nelle Università di Manchester, Nizza, Lione Lumière, Aix-en-Provence, Parigi XIII e Parigi XII. Nell'anno accademico 1999-2000 è stato titolare della cattedra Jean Monnet presso l'Università Dauphine Parigi IX.

E' membro del Consiglio di Indirizzo della Fondazione CRT e Presidente del Collegio Sindacale di Transalpina di Energia e Reply. In precedenza è stato Presidente del Consiglio di Corso di Laurea in "Produzione e organizzazione della comunicazione e della conoscenza" dal 2006 al 2012; Direttore del Dipartimento di Economia Salvatore Cognetti de Martiis dal 2004 al 2010, membro del Consiglio di Amministrazione di Telecom Italia (1998-99); Consiglio scientifico della Confindustria (1999-2000); Comitato Tecnico Scientifico dell'ENEA (2000-2004); Vice-President dell'International Schumpeter Society (1999-2004); membro del Consiglio di Amministrazione di Pegaso Investimenti (2008-2010) e Pirelli&C.
