CHINA AND SINOPHONE ASIA MOBILITY PROGRAM (CSAMP), 14th edition CALL FOR APPLICATIONS

*Up to 75 students from the CdLM in Scienze Internazionali will be selected to take part in
one of the following exchange programs:*

“China Studies Master Program at Zhejiang University” in Haining,

*“Master in International Relations, International Politics and Diplomacy at Tongji
University” in Shanghai,*

“Exchange program at Guangdong University of Foreign Studies” in Guangzhou,

“Exchange program at National Sun Yat-Sen University” in Kaohsiung,

“Exchange program at Nanyang Technological University” in Singapore,

which will be held at the partner Universities from September 2024 to June/July 2025.

1. Program profiles

Following the Department Council (CdD) decision on 29th January 2024, authorizing the publication of this Call, the Department of Cultures, Politics and Society of the University of Turin announces 75 positions for the China and Sinophone Asia Mobility Program 2024-25.

This scheme offers a unique opportunity to experiment real life in Sinophone Asia by spending one semester or one full academic year in Guangzhou, Haining, Kaohsiung,

Shanghai, or Singapore as a full-time student enrolled in one of the most prestigious universities in Sinophone Asia.

The 2024-25 edition of the program is open to a maximum of 75 participants from the University of Turin - CdLM in Scienze Internazionali, who will attend an exchange program in Sinophone Asia for international students.

China Studies Master Program at Zhejiang University (ZJU)

The China Studies Master Program is an inter-disciplinary program with a curriculum embracing knowledge of contemporary China, including its language, modern history, cultural heritage, ethnicity, political and legal institutions, socio-economic development and public management. The target student body is non-Chinese nationals with an intention of becoming China specialists or business/international affairs professionals with a China orientation.

The program is currently expected to take place from September 2024 to June/July 2025 at the Haining International Campus of Zhejiang University.

Students are required to earn up to 30 Chinese credits during their stay at Zhejiang University, in order to validate their year as part of the China Studies Program.

Most courses are taught in English. Optional courses on Chinese traditional culture are offered in Mandarin Chinese. Other activities and field trips organized by Zhejiang University are included in the Program.

Students are required to write a thesis at Zhejiang University and will be required to discuss their thesis for the Italian *Laurea Magistrale* in a joint panel of ZJU and UNITO professors in Turin. The joint thesis must be written in English. Participants are strongly encouraged to graduate from the *CdLM in Scienze Internazionali* by November 2025 in order to be granted the Chinese Master Degree without administrative delays.

Upon full attendance of the program and successful sitting of the final exams, participants are awarded:

- a China Studies Master's degree recognized by Chinese law;
- the recognition of 42 Italian CFU on their curriculum, of which 9 for thesis research. Grades are converted in the usual /30 format;
- the completion and discussion of the joint thesis allows students to obtain 9 CFU and to gain the points that are normally added to the average grades achieved during the two years of the *Laurea Magistrale* toward the final /110 grade.

Master Program in International Relations, International Politics and Diplomacy at Tongji University

Tongji University (TJU), formerly Tongji German Medical School, was established in Shanghai in 1907. It was given its present name and became a state university in 1927. It is one of the oldest and most prestigious institutions of higher education in China. The university has developed rapidly in all respects since the founding of the People's Republic of China, and especially since the country's opening-up policy. It is now a comprehensive university with ten major disciplines in sciences, engineering, medicine, humanities, law, economics, management, philosophy, arts and pedagogy with strength in architecture, civil engineering and oceanography.

The Double Degree program will take place from September 2024 to June/July 2025. Students are required to write a thesis at Tongji University and will be required to discuss their thesis for the Italian *Laurea Magistrale*. The joint thesis must be written in English. Participants are strongly encouraged to graduate from the *CdLM in Scienze Internazionali* in November 2025 in order to be granted the Chinese Master's degree without administrative delays. Upon full attendance of the program and successful sitting of the final exams, participants are awarded:

- a Master's degree in International Relations recognized by Chinese law;
- the recognition of 42 Italian CFU on their curriculum, of which 9 for thesis research. Grades are converted in the usual /30 format;
- the completion and discussion of the joint thesis allows students to obtain 9 CFU and to gain the points that are normally added to the average grades achieved during the two years of the Laurea Magistrale toward the final /110 grade.

Exchange program at Guangdong University of Foreign Studies

Guangdong University of Foreign Studies (GDUFS), created by a merger in 1995 of the Guangzhou Institute of Foreign Languages and the Guangzhou Institute of Foreign Trade, is a key provincial university and a high-tier one with distinctive features of internationalization in South China.

The exchange program lasts for one semester, either from September 2024 to January 2025 or from February 2025 to June/July 2025.

The exams to be taken at the GDUFS and the ones to be validated in the Italian study plan need to be approved in a learning agreement signed by the faculty member responsible for the program.

Exchange program at National Sun Yat-Sen University in the city of Kaohsiung

National Sun Yat-sen University (NSYSU), based in Kaohsiung (Taiwan) and founded in 1980, is one of the top-10 best universities in Taiwan, and it is located in the second largest city on the island. NSYSU is a strongly internationalized university having 60% of post-graduate students' population composed of international students.

The exchange program lasts for one semester, either from September 2024 to January 2025 or from February 2025 to June/July 2025.

Exchange program at Nanyang Technological University in Singapore

Nanyang Technological University (NTU) is one of Singapore's two major national universities. Founded in 1981, it is also the second-oldest autonomous university in the country. NTU is frequently ranked within the world's top-30 universities according to most major international rankings, and is widely-considered to be one of the two most prestigious universities in Singapore.

The exchange program lasts for one semester, either from September 2024 to January 2025 or from February 2025 to June/July 2025.

The exams to be taken at the NTU and the ones to be validated in the Italian study plan need to be approved in a learning agreement signed by the faculty member responsible for the program.

2. Who can apply

These programs are open exclusively to students currently enrolled in the first year of the *Laurea Magistrale in Scienze Internazionali* (LM-52) at the University of Turin. Exceptions are allowed for students who have enrolled directly in the second year of the *Laurea Magistrale in Scienze Internazionali* at the University of Turin on account of their transferring from another *Laurea Magistrale* (or equivalent Master's degree), and for students who are already enrolled in another Double Degree program promoted within the *Laurea Magistrale in Scienze Internazionali* at the University of Turin at the time of applying for one of the Exchange Programs lasting one semester offered in this Call.

Selected students for double degrees and first semester exchange mobilities may join the programs provided they have earned a minimum of 54 CFU in their current *Laurea Magistrale* by the end of the summer session (July 2024). Students undertaking their Exchange program in the second semester must have earned 54 CFU by the end of the autumn session (September 2024). **Failure to meet this condition will result in the exclusion from the Program.**

3. Selection criteria

The selection committee, composed of staff from the Department of Cultures, Politics and Society, will consider the following factors in making their decision: academic transcript, personal CV, proficiency in English, participation to activities organized within the *Scienze Internazionali* degree program, participation to programs organized by the TOChina Hub, knowledge of Chinese mandarin language, individual potential.

Candidates are interviewed individually before a final decision is taken.

Applicants who fail to meet the minimum required level determined by the selection committee (65/100 for the Exchange program, 70/100 for the Double Degree programs) will not be ranked.

4. Application process

Applications must be submitted by filling out [the relevant form attached to this Call](#).

Applications are accepted starting on February 12th 2024 until March 3rd 2024.

Applications must include:

- an up-to-date curriculum vitae in English;
- a cover letter in English, between 500 and 600 words, stating the reasons for applying to the program;
- a **full academic transcript in Italian** indicating the exams taken during the current Master's degree. The form must be downloaded from the applicant's MyUnito profile, filled and signed;
- a **full academic transcript in English** indicating the exams taken during the current Master's degree. The form must be downloaded from the [CSAMP section of the Department website](#) filled and signed;
- a **copy of the highest education certificate obtained so far (i.e. the *Laurea Triennale* degree), in Italian**, indicating exams and grades, the type of degree and the final grade.
- a **copy of the official Diploma Supplement in English, of the highest education level obtained so far (i.e. the *Laurea Triennale* degree)**, indicating exams and grades, the type of degree and the final grade. Only in case that the Diploma Supplement has been requested to the applicants' former university but not yet issued, candidates must fill and sign the relevant form that can be downloaded in the [CSAMP section of the Department website](#):
- a copy of your **IELTS/TOEFL score if already in possession**: it is **compulsory** to reach an IELTS Academic overall band score of at least 7/9 or a TOEFL iBT / TOEFL

iBT Home Edition score of at least 100/120 in order to participate in Double Degree programs. It is **compulsory** to reach an IELTS Academic overall band score of at least 6.5 /9 or a TOEFL iBT / TOEFL iBT Home Edition score of at least 90/120 in order to participate in Mobility Programs. Candidates have time until May 26th 2024 to acquire either of the above certifications. Successful candidates who do not possess the certification at the closing time of this Call will be ranked nonetheless *sub condicione*: should they fail to acquire the certification by May 26th 2024 they will lose their status as successful candidates and will not be allowed to participate in the Program;

- proof of **Chinese Language knowledge**, at least at the elementary level (e.g. the positive result of the Chinese language exam passed at the end of the first semester of the applicants' current Laurea Magistrale or HSK certificate);
- **copy of a passport valid** (in case you are applying for one at the moment, a copy of the application receipt and a copy of your Italian ID card must be submitted).

Applicants are encouraged to attach any further documents they deem relevant for their application, including evidence of relevant study or work experience abroad.

Incomplete applications will not be processed.

5. Scholarships

China Studies Master Program at Zhejiang University

Scholarships funded by the Chinese Government are available for the China Studies Master Program at Zhejiang University: the first 25 selected students applying for this program are provided with free accommodation at ZJU, plus a monthly allowance of CNY

1,700.00 (approx. EUR 245,00 at the current exchange rate). If additional funds are available, the number of scholarship recipients may be increased.

Double degree programs

Students selected for the Double Degree Programs (ZJU and Tongji) may receive the double degree International Mobility Scholarships (Borse di studio per la mobilità internazionale per doppio titolo) funded by the University of Turin, **pending budget availability**. Double Degree International Mobility Scholarships are awarded on the basis of the ranking of selected students, drawn up by the Department, **until the available budget is exhausted**. The monthly amount of the scholarships varies according to the ISEE value of the beneficiary and the country of destination (mobility in Group Zero Countries).

All selected students are provided with free tuition at the host university.

Participants are required to pay for other expenses, including visa, **compulsory personal advance-payment insurance**, flights and meals. Field trips are an integral, non-optional part of the programs and they are covered, in some cases, by scholarships.

6. Selection outcomes and acceptance

Final results of the selection procedure will be posted on the section “Bandi” of the Department website by 18/3/2024.

Successful candidates **must accept** the position offer and, starting from the first through to the last ranking position, and decide whether they want to attend one of the following programs:

- the China Studies Master's Program at Zhejiang University (up to 25 students admitted with a full scholarship funded by the Chinese Government, and 5 students tuition fee waiver but without scholarship);
- the Double Degree Master's Program at Tongji University (up to 15 students);
- the exchange program at Guangdong University of Foreign Studies (up to 16 students, 8 for each semester);
- the exchange program at National Sun Yat-Sen University (up to 4 students, 2 for each semester).
- the exchange program at Nanayang Technological University (up to 10 students, 5 for each semester).

The acceptance session will be held on 19/03/2024, starting from 09.30 am in room D4: candidates will receive the relevant information from the email address virginia.mariano@unito.it .

Failure to attend the public acceptance session will result in the exclusion from the ranking.

If a useful position in the ranking is revoked or refused by successful candidates, it will be offered progressively to candidates ranking immediately below.

7. Candidates upon their return from China

By 30th September 2025, all participants to the China Studies Programs are required to hand to the TOChina Program Officer all documents received by the host university testifying their studies in China (including learning agreement, attendance certificate, a synopsis of courses/activities pursued, and transcript of records). At the end of the

mobility closure process by the competent UNITO Office, the TOChina Centre will convert grades and CFU awarded within China and Sinophone Asia Mobility Program programs.
No recognition will be extended to students failing to pursue the agreed number of courses.
